Dear Pastor and Church family:

"Cast Thy Bread Upon the Waters..."

During this last month, I had the opportunity to speak with many different people about the Lord. Most conversations took place during Karen Baptist Church's regular church-wide evangelism, but there were also opportunities to hand out gospel tracts and have brief conversations with people inviting them to our church as I was out and about.

While out for evangelism, I met Winnie who was doing chores at home. Winnie allowed me to show her out of God's Word what God requires for salvation. She told me that she believed if she were to keep the Ten Commandments, she would get to heaven. I took a few moments to show her from God's Word how that by the works of the law "shall no flesh be justified" (Rom. 3:20a; Gal. 2:16). When I asked her, "Knowing what God's Word just said on the matter, would you be able to reach heaven (translation of Swahili expression) when you die?", Winnie's answer was "No." At this point, I fully expected her to trust Christ as her Savior; however, she was still holding on to her Catholic faith. Please pray for Winnie that the Lord would continue to work on her heart about trusting in Christ's work alone for her salvation.

I had the privilege of leading Peter Mwangi to the Lord a short while ago. Peter is a college student in Nairobi and lives too far from the church to walk. He must use public transportation to get to Karen Baptist Church on Sundays, funds
